ALL RACES WITH "PM" IN THE CONDITION MEANS PARI-MUTUEL WINS AT EXTENDED MEETS.

QUALIFIERS ARE ON THURSDAY MORNING AT 11:00 AM. BOX CLOSING AT 9 AM ON WEDNESDAY.

DO NOT CALL ABOUT POST POSITIONS UNTIL AT LEAST 1:00. THEY ARE NOT AVAILABLE UNTIL THEN.

HORSES MAKING LARGE CLASS DROPS WILL DO SO AT THE DISCRETION OF THE DIRECTOR OF RACING. RACES THAT DO NOT FILL OR HORSES NOT GETTING IN MAY BE MOVED TO A SIMILAR CLASS AT RACE OFFICE DISCRETION

HORSES THAT WIN A N/W LAST 4 CONDITIONED OR OPEN CLASS AT NORTHFIELD MAY NOT MOVE DOWN TO A LOWER CONDITION IN THEIR NEXT START, UNLESS THEY CARRY A CLAIMING TAG.

ALL TROTTER RACES WILL HAVE A SEPARATE DIVISION FOR FILLIES & MARES IF POSSIBLE.

NORTHFIELD PARK RESERVES THE RIGHT TO REFUSE ANY ENTRY IN AN OVERNIGHT RACE. HORSES ENTERED BY "NON LOCAL TRAINERS" MAY LOSE PREFERENCE TO HORSES ENTERED BY "LOCAL TRAINERS" AT THE DISCRETION OF THE DIRECTOR OF RACING. DRIVER CHANGES ARE DONE THE NIGHT OF THE DRAW ON NIGHTS WHEN WE HAVE LIVE RACING OR THE NEXT MORNING (8-9 AM) IF THERE IS NO LIVE RACING.
